The Seminar in Bioethics is intended as a capstone experience for bioethics majors, but it is open to anyone who has taken PHL 225 or 228 with permission of the instructor. In a discussion-based seminar format, we will examine the foundations of bioethics and then we will look at book-length treatments of several important issues, chosen by the participants as whole among topics like health care justice, global health justice, stem cell research, transplantation ethics, enhancement technologies, and issues in end-of-life care. The class satisfies the upper-level writing requirement.

Course Requirements:

 $Class \ participation$ is worth a significant portion of your grade. The class is based on student discussions, not on lectures. You are expected to come to class, and you are expected to come to class prepared to discuss the readings – if only to ask relevant questions about them. Most of your class participation grade is based on regular, substantive participation in class discussions.

Reflections. Every week, you are expected to write a brief (1-2 page) *reaction paper* to the week's reading, due at 7 a.m. each Friday. These papers should respond to some specific arguments or position in the readings by explaining why you agree or disagree with it. Please e-mail them to me.

Papers. There will be three papers in the course. The first two will be done using a tutorial system. I will give you a series of questions about particular texts. You will choose one topic and write a 6-9 page analytical paper. Class will be cancelled the week tutorials are due; instead, you and another student then meet with me in my office to hand in and discuss and hand in your papers, I will explain the tutorial method in more detail later.

For your final assignment, you will write a 9-12 page paper on a topic of your own choosing. Topics must be approved by me. Each student will write a first draft of the paper that

will be graded, and you will review one of those drafts from a peer. The final draft of the paper should then take into account both my comments and those from your classmate.
